Together with our publisher, Lippincott Williams & Wilkins, I am pleased to announce our annual competition to recognize the top Resident paper for the academic year 2016. The winning paper will be published in a forthcoming issue of the *Journal of Psychiatric Practice*. In addition, the primary Resident author will be invited to serve a 1-year term during 2017–2018 as a special Resident representative on the Editorial Board of the journal and will be invited to attend the Editorial Board Meeting during the 2017 annual meeting of the American Psychiatric Association. (If the winning resident cannot attend the meeting, he or she will receive a \$500 voucher, good towards the purchase of Lippincott Williams & Wilkins books and journals.) The winner will also receive a certificate from the *Journal of Psychiatric Practice* in recognition of this achievement.

When selecting the winning paper, the following criteria will be used:

- Originality
- Clinical relevance
- Scholarship
- Readability
- Overall value to the field of psychiatry

To participate in this competition, papers must be received by October 31, 2016. Review articles and papers based on original clinical research (but not single case reports), whose primary author is a resident, will qualify for the award. Submit all manuscripts to the Journal of Psychiatric Practice Editorial Manager website (www.editorialmanager.com/pr), selecting resident paper submission as the type of article. PREPARATION OF MANUSCRIPT

A submitted manuscript, which undergoes peer review, must be an original contribution not previously published (except as an abstract or preliminary report), must not be under consideration for publication elsewhere, and, if accepted, must not be published elsewhere in similar form, in any language, without consent of Lippincott Williams & Wilkins. Although the editors and referees make every effort to ensure the validity of published manuscripts, the final responsibility rests with the authors, not with the Journal, its editors, or the publisher.

Conflicts of interest: Authors must state all possible conflicts of interest in the manuscript, including financial, consultant, institutional, and other relationships that might lead to bias or a conflict of interest. If there is no conflict of interest, this should be explicitly stated as none declared. All relevant conflicts of interest and sources of funding should be included on the title page of the manuscript under the heading "Conflicts of Interest and Source of Funding." For example: "Conflicts of Interest and Source of Funding: A has received honoraria from Company Z. B is currently receiving a grant (#12345) from Organization Y, and is on the speaker's bureau for Organization X. For the remaining authors none were declared."

Each author must also complete and submit the journal's copyright transfer agreement, which includes a section on disclosure of potential conflicts of interest based on the recommendations of the International Committee of Medical Journal Editors (www.icmje.org/update.html). The form is available on the manuscript submission page (www.editorialmanager.com/pr) and can be completed, signed, and submitted electronically.

Patient anonymity/informed consent: It is the author's responsibility to ensure that patients' anonymity is carefully protected and verify that any experimental investigation with human subjects reported was performed with informed consent and following all guidelines for experimental investigation with human subjects required by the institution(s) with which all the authors are affiliated.

Permissions: Authors must submit written permission from copyright owners (usually a publisher) to use lengthy direct quotations, tables, or illustrations that have appeared in copyrighted form elsewhere.

General format: Manuscripts should be double-spaced and formatted for 8½ x 11-inch paper, with a 1-inch margin on all sides.

Title page: manuscript title; authors' full names, highest academic degrees, and affiliations; name, address, telephone number, and email for corresponding author; sources of support requiring acknowledgment, and

disclosure of funding for this work from any of the following organizations: National Institutes of Health (NIH); Wellcome Trust; Howard Hughes Medical Institute (HHMI); or industry.

Abstract and key words: 250 words plus at least 5 key words.

Text: Use headings to clarify organization. Indicate where tables and figures should appear. Define abbreviations at first mention in the text and in each table and figure.

References: Authors are responsible for accuracy of references. Place references at end of the manuscript and cite numerically in text in order of appearance. Cite unpublished data (papers submitted but not accepted, personal communications) in parentheses in the text. If more than 3 authors, list first three and then use et al. Use Index Medicus abbreviations for journal names (www.nlm.nih.gov/tsd/serials/lji.html). Samples are given below:

Figures: Cite and number figures consecutively in the text. Submit figures in electronic form (e.g., pdf, tiff, eps files). Include brief legends for figures at the end of the manuscript.

Tables: Tables should supplement, rather than duplicate, material in the text. Cite and number tables consecutively in the text and place them at the end of the manuscript. Include table title, column heads, and explanatory legends (including definitions of abbreviations).

Supplemental Digital Content (SDC):

Authors may submit SDC that enhances the article's content to be considered for online posting. For more information on how to submit SDC, authors are referred to the online Instructions for Authors at: <http://edmgr.ovid.com/pr/accounts/ifaauth.htm>.

Style: Use Stedman's Medical Dictionary (28th edition) and Merriam Webster's

Collegiate Dictionary (11th edition) as standard references. Refer to medications by generic or chemical names with trade names in parentheses at first mention. To comply with trademark law, include name and location (city/state in US and city/country outside US) of manufacturer of any drug, supply, or equipment mentioned in the manuscript. Use metric system for units of measure and degrees Celsius for temperatures; use SI rather than conventional units.

AFTER ACCEPTANCE

Compliance with NIH and other research funding agency accessibility requirements:

A number of research funding agencies require/request authors to submit the postprint (article after peer review and acceptance but not the final published article) to a repository accessible online by all without charge. As a service to our authors, LWW identifies to the National Library of Medicine (NLM) articles that require deposit and transmits post-prints of articles based on research funded in whole or in part by the National Institutes of Health, Wellcome Trust, Howard Hughes Medical Institute, or other funding agencies to PubMed Central. The revised Copyright Transfer Agreement provides the mechanism.

Copyright: Each author must complete and sign a copy of the journal's "Authorship Responsibility, Disclosure, and Copyright Transfer" form. The corresponding author is responsible for coordinating submission of coauthors' signed forms along with the text files at www.editorialmanager.com/pr.

Page proofs and corrections: Corresponding authors will receive a pdf of the page proofs to review before publication. It is the author's responsibility to ensure that there are no errors in the proofs.

Reprints: Authors receive information on ordering reprints from the publisher when page proofs are prepared. An order confirmation will be emailed to you. Reprints are normally shipped 6 to 8 weeks after publication. For commercial reprints and quantities of 500 or more, email reprintolutions@wolterskluwer.com.
